

## WHAT IS MC2CM?

Migration is a defining feature of urbanisation. Cities are places where people come together to live, work and find opportunities. It is also in the city where the reality of social and economic accommodation of newcomers and their interaction with host community takes place.

In this context, the Mediterranean City-to-City Migration project (MC2CM) contributes to improved rights-based migration governance in cities. Through dialogue, knowledge and action, MC2CM anchors migration governance to a process of urban planning.



### DIALOGUE

Nurturing dialogue between cities and relevant stakeholders through peer to peer learning and exchanges.



### KNOWLEDGE

Supporting knowledge generation and development of evidence-based approaches through identification and prioritisation.



### ACTION

Providing sustainable solutions and testing tools to address migration-related challenges and opportunities.

## MAIN ACHIEVEMENTS OF PHASE I

In the first phase of MC2CM, the participating cities, Amman, Beirut, Lisbon, Lyon, Madrid, Tangier, Tunis, Turin and Vienna established an open dialogue, developed and exchanged knowledge and developed local projects to address identified priorities, with the support of the implementing partners ICMPD, UCLG and UN-Habitat.

The Mediterranean City-to-City Migration Project is starting its new phase from **2018–2021**, with new and expanded objectives:



### EXPAND DIALOGUE

More cities and stakeholders involved in exchanges and enriched panel of learning activities



### DEVISE MORE ACTION

Supporting targeted city actions to address identified needs and priorities on the ground



### INCREASE KNOWLEDGE

Collection and dissemination of migration-related knowledge and data



### RAISE AWARENESS

Promoting a realistic and fair narrative on migration intercultural dialogue

INNOVATIVE APPROACHES

- Focus on cities and local governments as key actors of migration governance
- Seeking involvement of national actors to stimulate multi-level governance approach
- Cross-cutting activities on balancing the narrative on migration
- Online tools that aim to support cities to improve rights-based migration governance
- Policy Recommendations tracking progress made in participating cities
- MC2CM has been presented in Habitat III and the World Urban Forum 9 as a best practice to implement the New Urban Agenda
